50. APOLOGIES

51. DECLARATIONS OF INTEREST

52. MINUTES OF MEETING HELD ON 27TH APRIL 2012

The minutes of the meeting held on 27th April 2012 were agreed as a correct record of the decisions taken subject to the following amendments: page 5 the premise to be replaced with local premises and page 6 penultimate paragraph last sentence to be deleted. The amendments had been requested from one of the interested parties who had attended the meeting.

53. LICENSING ACT 2003: APPLICATION FOR THE GRANT OF A PREMISES LICENCE, BOURNE PUBLIC HOUSE, JUNCTION OF SOUTH ROAD AND RAYMOND MAYS WAY, BOURNE

Decision:

That the application for a premise licence for the Bourne Public House at the junction of South Road and Raymond Mays Way Bourne be approved as applied for with the addition of a condition that all windows and doors will be kept shut during live and recorded music, save for access and egress and the application for Late Night Refreshment be granted for indoors only.

The Licensing Officer presented report CSL011 which concerned an application received on behalf of Marston's PLC for a premises licence for premises that will be known as Bourne Public House, the premise had yet to be built. The applicant had requested a permit for all activities as listed within the report and until midnight on Sunday and Monday on bank holiday weekends, Christmas Eve, Boxing Day, New Years Day and All Saints Day and New Years Eve 10.00am to 01.00 on the 2nd January. The application was also to serve alcohol to residents and their bona fide guests, the Licensing Officer had asked for clarification on this point as there was no accommodation on site. Due to how the tills were configured if the manager required a drink once the premise was closed he would be classed as a resident. A premise licence had already been applied for and granted but as the location of the building had changed slightly a new licence had been applied for and if approved the old licence would be surrendered. An objection had been received from the Environmental Protection Team. They wanted a condition added to the licence stating that "all doors and windows to be kept shut at all times during live and recorded music save for access or egress". The applicants were happy for the condition to be attached.

Members of the panel asked for clarification on points raised especially in connection with the configuration of the till. The Licensing Officer suggested that if members wished for more information the meeting could be adjourned. Members decided to continue with the hearing. A question was raised about the times shown in sections L and D pages 12 and 16 of the application as there seemed to be a contradiction on the application. The Licensing Officer clarified the correct time. It was proposed, seconded and unanimously agreed to grant the licence as applied for subject to the addition of the condition that all doors and windows to be kept shut at all times during live and recorded music save for access or egress and the application for late night refreshment be granted for indoors only.

Members had raised concern about the new arrangements concerning the configuration of the till the Licensing Officer indicated that he would once again contact the applicants and report back to the next Committee on his findings.

1. RECOMMENDATIONS

1.1 It is recommended that the Alcohol, Entertainment and Late Night Refreshment Licensing Committee ("the Committee") consider the application for a review of the Premises Licence relating to a premises known as European Mini Market, Wharf Road, Grantham and determine either to:

- a. modify the conditions of the licence;
- b. exclude a licensable activity from the licence
- c. remove the designated premises supervisor;
- d. suspend the licence for a period not exceeding 3 months; or
- e. revoke the licence.

If the Committee decides that none of the above steps are necessary then it need take no action.

2. PURPOSE OF THE REPORT

- 2.1 The purpose of this report is to provide the committee with information to enable it to consider this application for a review of the premise licence under Section 51 of the Licensing Act 2003 ('the Act').
- 2.2 Where a relevant application for a review is received, the Licensing Authority must hold a hearing to determine the application. The options available to the Committee are as detailed in the recommendation application:

The guidance issued under Section 182 of the Act is:

"In deciding which of these powers to invoke, it is expected that licensing authorities should, so far as possible, seek to establish the cause or causes of the concerns which the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than a necessary and proportionate response."

3. DETAILS OF REPORT

- 3.1 Lincolnshire Police are asking for a review of the Premises Licence for the European Mini Market on Wharf Road in Grantham, (appendix 1).
- 3.2 Law enforcement agencies had identified through intelligence, the possibility that alcohol and other goods were being made available for retail sale in contravention of the Customs and excise Management Act 1979 and the Tobacco Products Duty Act 1979.
- 3.3 On 8 February 2012 a joint visit consisting of officers from Lincolnshire Police, Trading Standards and Her Majesty's Revenue and Customs entered the store and seized a total of 3280 cigarettes, 2.42 Kilos of tobacco and 24.8 Litres of non duty paid vodka.
- 3.4 The cigarettes and tobacco were hidden in a purpose built store, concealed underneath the counter and accessed by pulling on what has been described by the police as 'false power sockets' to reveal a sliding door with the cigarettes hidden behind. This was only discovered after an indication by a dog trained in the detection of cigarettes/tobacco.
- 3.5 All the cigarettes found were foreign brands, none were UK duty paid marked and HMRC Officers have confirmed in their statement attached at appendix 1 that they should not have been for sale in this country.
- 3.6 The Premises Licence Holder was present at the time of the visit
- 3.7 On the 11th of February 2012 an incident of serious violence and disorder occurred which required immediate police attendance at which six people were arrested for affray. All persons involved in the affray have been uncooperative with police in explaining what the cause of the incident was and the police strongly believe it was caused by an argument over payment of the seized goods.

- 3.8 On the 2nd of March 2012 the police attended another incident involving fighting at the premises. A male arrested and subsequently charged with assault was clearly heard to say “do not talk to the police”. The police believed he was referring to the earlier affray and seizure. Please see page 4 of appendix 1.
- 3.9 The police say this serves to demonstrate that that management of the premises is ineffective because they are failing to promote the licensing objective of the Prevention of Crime and Disorder
- 3.10 The Police say that they are unable to offer any conditions that could prevent a reoccurrence of such criminal activity and they ask that serious consideration should be given to revocation of the licence
- 3.11 Trading Standards have submitted an e mail and three statements(appendix 2) supporting the review application and have included evidence relating to test purchase operations they carried out in January and May 2012 and the role they undertook when assisting Her Majesty’s Revenue and Customs and Lincolnshire Police with the counterfeit goods operation.
- 3.12 Bird and Co, Solicitors for the applicant, have submitted a statement (appendix 3) on behalf of the Premises Licence Holder in which he admits the offences relating to tobacco pouches and cigarettes but disputes the offences in relation to the alcohol.
- 3.13 The Premises Licence Holder also says that he did not construct the cabinet under the counter to conceal the cigarettes but to store cash and other valuables.

4. OTHER OPTIONS CONSIDERED

There is no other option than to hold a hearing

10. COMMENTS OF LEGAL AND DEMOCRATIC SERVICES

10.1 The Act provides a procedure whereby a premises licence can be reviewed at any time on the application of an interested party or a responsible authority. On receipt of an application for review of a licence, the Council are obliged to hold a hearing to consider the application within 28 days of receipt of the application. The Committee should consider the Guidance issued under S182 of the Act and the Council's own statement of licensing policy when considering if the application merits evidence that the licensing objectives are being undermined or not.

10.2 The licensing objectives are:

- Prevention of Crime & Disorder
- Public Safety
- Public Nuisance
- Protection of Children from harm

10.3 Any decision taken by the Committee should be reasonable and proportionate and must be appropriate for the promotion of the licensing objectives. The decision of the committee should be no more than a proportionate response to the concerns raised by the police.
