56. APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Bevan, Broughton, Higgs, Mrs Kaberry-Brown, King, Parkin and Wells.

58. MINUTES OF THE MEETING HELD ON 23 JANUARY 2014

The minutes of the meeting held on 23 January 2014 were proposed, seconded and agreed as a correct record.

59. COMMUNICATIONS (INCLUDING CHAIRMAN'S ANNOUNCEMENTS)

The Chairman's communications were noted. Members' attention was drawn to a typographical error on the engagement for 28 February 2014. The description of this event referred to Grantham town council however there was no town council in Grantham.

60. AMENDMENT TO STANDING ORDERS

Decision:

That the Council adopts the requirements of the Local Authorities (Standing Orders) (England) (Amendment) Regulations 2014 relating to recorded votes for budget decisions and approves the amendment to the Constitution to incorporate the amendment in the Council Procedures and the Budget and Policy Framework Rules as follows:

- ***Council Procedures at page 135 of the Constitution, paragraph 16.4***

And

- ***Budget and Policy Framework Procedure Rules at page 164, paragraph 3***

With the words:

"A recorded vote shall be taken in respect of any vote for a decision or against a decision or any abstention from voting on any decision relating to the making of calculations in accordance with the Local Government Finance Act 1992 at any budget decision meeting of the Council."

In proposing the recommendations in report number LDS120 on changes to Standing Orders for voting on Budget decisions, the Portfolio Holder for Governance and Communication explained that the change was necessary because of new Regulations. The proposition was seconded. In response to a question, the Monitoring Officer clarified that the new Standing Orders would only cover votes on substantive items, not proposed amendments.

On being put to the vote the proposal was carried.

- f) £1,993,759 being the aggregate amount of all special items referred to in Section 34(1) of the Act.**
- g) £127.47 being the amount of e) above, less the result given by dividing the amount of f) above by the Council's tax base relating to special items as set on 2 December 2013, calculated by the Council in accordance with Section 34(2) of the Act, as the basic amount of its Council Tax for year for dwellings in those parts of its area to which no special item relates.**
- h) Part of the Council's area being calculated by adding to the amount at (g) above the amounts of special item relating to dwellings in those parts of the Council's area, divided in each case by the individual tax bases as recorded in minute 33 in accordance with Section 34(3) of the Act, as the basic amounts of its Council Tax for the year for dwellings in those parts of its area to which special item relates.**

the Local Government Finance Act 1992, hereby sets the amounts in Appendix B to Part B of report number HOF267 as the levels of Council Tax for the year 2014/15 for the categories of dwellings shown in Appendix A to Part B of report number HOF267.

In proposing the budget for 2014/15 and indicative budgets to 2016/17 – General Fund, Housing Revenue Account and associated capital programmes as presented in report number HOF267, the Leader drew Members' attention to some of the work that had taken place in 2013/14 and plans for 2014/15. She referred to projects that promoted the district including the Stamford Georgian Festival, Destination SK and a pilot fund to support new businesses. She also made reference to Gravity Fields 2014 and Enterprise Week. She framed the proposed budget in the context of the national economy, which was showing signs of improvement, while highlighting the need to make ongoing savings while investing in those areas that were priorities for the district's residents. The proposal was seconded.

The Portfolio Holders for Strategic Resources – Well Run Council and Good Housing each spoke about a range of issues relevant to their Portfolios:

General Fund

- Continuing reductions in the level of Revenue Support Grant
- The rate at which funding reduction has occurred
- Retention of some income from business rates
- The production of a new Medium Term Financial Strategy
- The achievement of £2.4m savings over three-years while continuing investment in council priorities

Housing Revenue Account

- Construction of new council housing
- The impact of the self-financing of the Housing Revenue Account (HRA) on the HRA business plan and its ongoing review
- Development of a new medium term Housing Strategy, Housing Revenue Asset Management Strategy and updated Tenancy and Allocations Policies
- Delivery and maintenance of the decent homes programme for council properties
- Changes to the method of delivery of the Repairs service
- The impact of the government's policy of rent convergence on council tenants

An amendment proposing a district councillors' community fund was proposed and seconded:

"I propose that a district councillors Community Fund of £500pa per Councillor (total £29,000pa) is established to be spent on local community projects.

Individual Councillors will be responsible for proposing or supporting local community projects in their Ward area and have a budget of up to £500 to allocate.

The scheme will run as a pilot for a 2-year period covering the years 2014/15 and 2015/16. After this period the scheme will be reviewed.

The Head of Finance will be responsible for approving the expenditure following submission of an appraisal form submitted by the Councillor.

The appraisal will have to demonstrate that the project

- *Supports one of SKDC's key objectives*
- *Is a benefit to the local community*
- *That there is a need in the local community for the project*
- *That it is value for money*

The budget for this would be financed from the General Fund Reserves 'other priority and service improvements' which shows an estimated balance of £1.187m as at 31 March 2014

This amendment would retain the proposed Council Tax levels and maintain a robust overall budget."

Those Councillors who spoke in support of the amendment highlighted the potential advantages such a fund could provide for local community groups, citing specific examples of local sports clubs and communities wishing to acquire a defibrillator. Comparisons were drawn with a similar scheme run by Lincolnshire County Council (referred to favourably), where Members had £2,000 to spend on community projects in their division. One Councillor read from a paper that had been produced when the issue was previously proposed. The localism agenda and the role of the Councillor in the local community were also put forward as arguments in favour of the proposal; also mentioned was the expectation for local communities to take responsibility for delivering services previously provided by the County Council (e.g. libraries).

Members speaking against the amendment referred to the complexity of the administration of such a fund, negative experiences of the County Council scheme and the risk that the funding could be used to raise the profile of incumbent councillors seeking re-election in 2015, also that direct links between the amendment and Council priorities should have been highlighted. It was further suggested that the proposing of any such scheme might more appropriately be addressed through the Council's policy development process.

In accordance with council procedure rule 16.4 a request was made for a recorded vote. As the request received the support of more than ten Members, a recorded vote was duly taken.

A question was asked on the HRA element of the proposed budget; Members were informed that where it was appropriate the council would look at buying back properties in favour of new build, for instance when there was a single flat amidst a block of council-owned flats.

A further amendment to the budget was proposed and seconded:

“It is recommended that SKDC approves the implementation of a First 2 Hour Free Parking on Saturdays Pilot Scheme for Grantham and Stamford short term car parks for the duration of 201/15 at an estimated cost of £64k.

The pilot will allow visitors to Grantham and Stamford town centres to obtain a parking ticket with the first 2 hours parking free. Visitor may opt to top this up if they wish to stay in the short-term car park longer.

The scheme will offer the opportunity to identify the impact of free parking on Grantham and Stamford town centre local economies. It will also support Grantham Saturday market encouraging visitors to Grantham on market day.

During the Pilot the impact on footfall and shop revenue will be monitored to identify if there has been an increase in footfall and/or customer spend.

The budget requirement of £65k (sic) is based on the cost of implementation and

estimated lost car parking revenue.

The fund would be taken from the General Fund Reserve Statement item General Fund – Revenue Reserves – Community Based Initiatives – Other priority and service improvements. This fund is shown as being £1.787m balance at 31 March 2014 with forecast balance at 31 March 2017 showing at £860k at present. The proposed Movement on Reserve is £600k for 2014/15. It is proposed this is amended to £664k to support the pilot scheme.

Given a priority objective of SKDC is economic development, the proposed means of funding this scheme is appropriate and should be supported.

Should the 2hr Saturday free parking scheme be successful then a review of future funding will take place. It has however been identified that marginal increases across car park fees would make the scheme self-funding in future.

NOTE: Bourne and Market Deeping already have free parking and are therefore exempt from the scheme.”

In proposing the amendment, specific reference was made to reports in the local media and requests from local businesses, supporting local markets and SKDC's 'Grow the Economy' priority. A similar scheme had been trialled by local businesses although there was no evidence available to demonstrate any outcomes. It was hoped that the proposal would drive visitors to SKDC car parks with the opportunity to top-up rather than car parks at supermarkets and retail parks, with strict, non-extendable time limits.

Those speaking against the amendment challenged whether it would have the desired effect of encouraging people to stay in town centres for longer; they suggested that people would try and deal with all their business before the free parking period expired. There was a feeling amongst members who did not support the amendment that the local offer was more important than the cost of parking. Reference was made to increased availability of on-street car parking in Stamford since the introduction of Civil Parking Enforcement. Again it was suggested that the proposal might have most appropriately been discussed at Resources PDG as part of its considerations on car parking charges. The Economic Development Portfolio Holder added that while the proposers claimed to be speaking on behalf of local businesses, no similar requests had been made directly by local business people to the Council.

Members were informed that the cost of the proposed scheme (£64k) included implementation and loss of earnings but did not include any costs associated with monitoring and analysing outcomes.

The proposer of the original motion was given the opportunity to sum-up. She urged Councillors to vote against the amendment. On being put to the vote, the amendment was lost.

16:09-16:30 The meeting adjourned

Debate on the substantive proposition continued. Comments were made relating to a range of topics:

- The Right to Buy was protected by legislation but there was a floor below which the price to buy could not fall
- Provision of 'green' accommodation and efforts to reduce the likelihood of households falling into fuel poverty
- The increase shown in the revenue reserves was the annual payment of New Homes Bonus
- Savings of £100k were achieved through re-letting of the grounds maintenance contract
- 4 apprentices had been taken on by the Repairs teams; provision for future apprenticeships had been mainstreamed in the HRA
- Ongoing provision of the Council's frontline services had not been affected by reductions in funding
- If interest rates were to unexpectedly improve, then the council would experience improved performance on overnight and future investments.

In summing up the Leader addressed all the points raised by those Councillors who spoke on the budget proposals. She re-stated about the drive for promoting the district and improving the local economy. She also referred to the Local Authority Mortgage Scheme, the council's community wifi scheme and the proposals to redevelop St Catherine's Road in Grantham. She said that the proposed budget would enhance the environment, promote economic growth and protect the most vulnerable, supporting the Council's priorities and moving towards a sustainable footing in the future.

The proposals were put to the vote in blocks, as per the recommendations in report number HOF267 and detailed below.

(Councillors J Kerr, V Kerr and Turner had left the meeting before the votes were taken).

Report number LDS119 explained that the Council was required to make appointments to the three internal drainage boards that operated in South Kesteven. The Leader proposed the following appointments, which were seconded.

An amendment was proposed and seconded:

“That those wishing to be considered to serve as this Council’s representatives on outside bodies be given the opportunity to put forward a written resume of the experience and qualifications relevant to the particular role under consideration, to enable councillors to properly consider each candidate on their merit to ensure that this Council appoints the best possible representatives to outside bodies.”

As the meeting had been in progress for almost three hours, it was proposed and seconded in accordance with Council Procedure Rule 14.10(vii) that the meeting should continue. On being put to the vote this was carried.

Those Members who spoke against the amendment highlighted ongoing business on the drainage boards where continuity was critical. There was also some concern that the proposed amendment would delay appointments. Opponents also challenged that the only members who would be able to evidence suitable skills and experience were those who already represented the Council on the drainage boards. Reference was made to current arrangements which had seen those nominating a prospective representative summarising the reasons they believed them to be suitable for the role.

The Members who supported the amendment felt that presenting a resume would clearly evidence an individual’s suitability and enthusiasm for a post. They also acknowledged that in many instances the incumbent was likely to be the candidate with relevant experience and knowledge, particularly in respect of appointments to specialist bodies like internal drainage boards. It was added that there would be no need to delay making appointments to the Internal Drainage Boards if the Council approved the principle for use when making future appointments.

On being put to the vote, the amendment was lost. A vote was taken on the substantive motion, which was carried.

Following the vote, Councillor Smith as the Council’s representative on the Local Government Association Rural Commission gave a brief update. Report number LDS119 explained that the Local Government Association Urban Commission had been disbanded; Councillor Smith explained that the Rural Commission had been similarly disbanded and would be replaced by a People and Places Board.
