There has been a development in the Civil Penalty.

I received this correspondence from the Civil Penalty team earlier today, if this supplementary information could please be included. I have also passed on this information to Katherine Braithwaite;

A Civil Penalty Notice (CPN) for £45,000 will be issued on Friday 12 December 2025 to Shiv Sakthi UK for employing one person who has no right to work in the UK. The CPN has a given date of Monday 16 December 2025.

Shiv Sakthi UK will have until 12 January 2026 to object to the penalty. The penalty will be due for payment on 13 January 2026.
