1 The Background to the Report

- 1.1 Further to the publication of the report on political proportionality and allocation of committee seats as part of the agenda for this meeting, notice under Regulation 8 of the Local Government (Committees and Political Groups) Regulations was provided to the Chief Executive on 21 July 2022 that a new political group at South Kesteven District Council has been established.
- 1.2 The name of the new political group is Alliance SK and consists of Councillors Ashley Baxter (Group Leader), Phil Dilks (Deputy Leader), Virginia Moran and Charmaine Morgan.
- 1.3 Councillors Baxter, Dilks and Moran were previously aligned with the Council's Independent Group and Councillor Morgan was an independent unaligned Councillor.
- 1.4 Appendix A of this report sets out the revised political proportionality and allocation of committee seats, with the resulting changes being the allocation of committee seats to the Alliance SK political group as follows:
 - Constitution Committee (one seat from the Independent Group)
 - Companies Committee (one seat from the Independent Group)
 - Culture and Visitor Economy Overview and Scrutiny Committee (one seat from the Independent Group)
 - Employment Committee (one seat from the Independent Group)
 - Environment Overview and Scrutiny Committee (one seat from the Independent Group)
 - Finance, Economic Development and Corporate Services Overview and Scrutiny Committee (one seat which is currently vacant arising from the former Labour Group)
 - Governance and Audit Committee (one seat from the Independent Group)
 - Licensing Committee and Alcohol, Entertainment and Late Night Refreshment Licensing Committee (one seat from the Independent Group)
 - Planning Committee (one seat which is currently vacant arising from the former Labour Group)
 - Rural and Communities Overview and Scrutiny Committee (one seat from the Independent Group)
- 1.5 The Alliance SK Group is invited to nominate members to the Group's allocated seats.
- 1.6 The Independent Group is invited to confirm its membership on those Committees where seats have been re-allocated to the Alliance SK Group.
- 1.7 This report provides all political groups with the opportunity to consider their respective membership on the Council's Committees.
- 1.8 Appendix A to this report also corrects an error in the appendix to the originally published report, confirming that the Governance and Audit Committee consists of 7 Members of the Council as opposed to 9.
