12. Apologies for absence

Apologies for absence were received from Councillors Pam Bosworth, Jane Kingman, Nikki Manterfield and Steven Cunningham.

Councillor Elvis Stooke acted as Chairman, for this meeting only.

13. Disclosures of interests

There were none.

14. Minutes of the meeting held on 6 December 2024

It was proposed, seconded and **AGREED** to approve the minutes of the meeting held on 6 December 2024 subject to minor amendments.

15. Licensing Act 2003: Review of Premise Licence - Istanbul Grill, 26 High Street, Grantham, NG31 6PH

The Legal Advisor introduced those present and confirmed who was present from Lincolnshire Police, Sergeant Adams and PC Braithwaite as well as the Applicant.

The Licensing Manager presented the report which concerned a review of Premise Licence for Istanbul Grill, 26 High Street, Grantham, NG31 6PH.

On Thursday 19th December 2024 an application for the review of the premise licence for Istanbul Grill, Grantham was received from Lincolnshire Police along with supporting documents.

The application for review related to the following licensing objectives: -

- Prevention of crime and disorder.
- Protection of Children from harm.

Lincolnshire Police advised that they had obtained evidence which indicates that the management of this premises had been operating in such a manner that amounts to criminal activity and thus undermines the licensing objectives:

- Employment of two illegal workers
- Breach of its annex 2 premise licence conditions.

On 23rd December 2024 a representation was received from Immigration officers in support of the police review.

On 30th December 2024, the Licensing Officer, attempted to erect a notice at the premises, however the premises was shut.

On 7th January 2025 a notice was erected on the outside of the premises by the Licensing Officer following numerous attempts to gain entry since 30th December 2024.

No further representations had been received.

The current licence holder had held the premise licence for this premises since March 2022. This was a new premise licence application at the time.

There has been no previous recorded incidents at this premise in the past.

The next steps were for the Committee to decide whether to:

- modify the conditions of the licence;
- exclude a licensable activity from the licence;
- remove the designated premises supervisor;
- suspend the licence for a period not exceeding 3 months; or

- revoke the licence.

There were no questions to the Licensing Manager at this stage.

Lincolnshire Police had no questions for the Licensing Manager.

Lincolnshire Police provided their representation.

On the 1st August 2024, Immigration officers attended Istanbul Grill following information received that the premises was employing illegal workers. Two illegal workers were located working in the kitchen. Both had outstanding asylum claims and no permission to work having previously been served notices as overstayers.

Immigration Officers were informed that the owner of the business was away on holiday with his family. A civil penalty referral notice (CPRN) was completed and left with the front of house worker who said he was in charge at that time. He was the only legal worker at the premises at the time and due to being unable to find other staff to operate the business, he closed the restaurant. This proved the reliance on the illegal workforce.

The premises licence holder (PLH) and designated premises supervisor (DPS) was a Ms Zohreh Hosseini. Ms Hosseini held the premises licence since 2020 and had been the DPS since March 2022.

On the 4th October 2024 Immigration issued a Civil Penalty Notice for £90,000 to Hos Catering Ltd, which was due for payment on the 5th November 2024. No objection was made to the Penalty Notice and as it stands, Lincolnshire Police are informed that the payment remains outstanding.

Ms Zohreh Hosseini has been the sole director of 'HOS Catering Ltd' (company number 12122091) since its incorporation on the 25th July 2019.

On the 9th October 2024 Police Licensing Officers attended the premises unannounced to complete a licensing inspection. The purpose of the visit was to ensure the premises was operating within the remit of its premises licence and associated conditions. Mr Amir Nazar was present and described himself as being in charge of the business. He stated Ms Hosseini was his wife and she was not present at the time.

During the inspection, multiple annex 1 and 2 conditions of the licence were not being complied with which amount to s.136 offences under the Licensing Act 2004. PC Braithwaite's statement outlined details of the inspection and all the areas of non-compliance.

Included within the annex 2 conditions, is a requirement for the premises to ensure a personal licence holder is at the premises at all times during licensable activities. This was not being adhered to. Mr Nazar had initially given reassurance that

alcohol was never served unless his wife was present, however a re-visit around 1 hour later, found customers present at tables with pints of beer who Mr Nazar admitted he had served the alcohol without his wife or another personal licence holder being present. This casted serious doubt over Mr Nazar's integrity.

On the 15th October 2024 PC Braithwaite sent an email to Ms Hosseini highlighting the many areas of non-compliance discovered on the 9th October 2024. The email was sent to the personal email address of Ms Hosseini provided by Mr Nazar on the 9th October 2024. The email requested Ms Hosseini respond with her proposed actions to address the issues raised. To date, Ms Hosseini has failed to respond at all.

In addition to the recent issues presented to Lincolnshire Police, historically there had been concerns surrounding Mr Nazar and Ms Hosseini which were outlined:

- In 2018 Mr Nazar was convicted for 8 offences committed in relation to counterfeit cigarettes and tobacco:
- 2 offences under the Proceeds of Crime Act 2002 - facilitate the acquisition/acquire/possess criminal property and 6 offences under the Trades Marks Act 1994
- 6 offences of possession of goods with a false trademark for sale.

These convictions followed a compliance visit to a shop in Grantham for which Ms Hosseini was the Director, and where counterfeit cigarettes and tobacco were discovered. Another individual was the Licence Holder and DPS for this premises at the time, but during the inspection, Ms Hosseini and Mr Nazar were present. Also at the time, Mr Nazar was working in the shop with no right to work.

Lincolnshire Police previously submitted a premises licence review for this particular premises. The premises licence was revoked by the committee. This highlights Ms Hosseini's and Mr Nazar's links previously to criminality. In conjunction with the latest criminal activity discovered at Ms Hosseini's current premises, the police have no confidence in Ms Hosseini's ability to uphold the licensing objective of the prevention of crime and disorder.

Lincolnshire Police have also not been assured that the premises will uphold the licencing objective of the protection of children from harm, in light of their apparent lack of age verification policy, appropriate staff training and signage. None of these conditions listed within the premises licence could be evidenced at all during the recent police visit to the premises.

Lincolnshire Police respectfully requested that the committee seriously consider the revocation of this premises licence.

Following question from Lincolnshire Police, the Applicant provided their statement which outlined the following:

- That two individuals who work on the premises had provided their Visas and Passports.
- The Applicant was unaware that the licence holder being present was a 24-hour provision.
- That any workers on the premises were not paid cash in hand.

The Committee raised the following questions to the Applicant:

- Whether the Applicant took copies of the Visas and Passports and produced them when requested by Lincolnshire Police.

The Applicant confirmed he took copies of the documentation.

- It was queried why the Applicant had not paid the £90,000 Civil Penalty Notice from Immigration.

The Applicant stated his matter was with their solicitor.

- Whether the Applicant understood that the absence of the personal licence holder at the premises at all times during licensable activities was against licensing laws.

The licence holder stated that she occasionally would have to collect her children and would therefore have to leave the premises.

- Whether the Applicant understood the laws of licensing when the licence was applied for and why the responsibilities were not fulfilled.
- One Member queried why larger measurements had been served of alcohol on the premises.
- A query was raised on whether the Applicant kept training records, which was essential.

The Applicant stated there were no training records available.

There were no further questions at this point.

Lincolnshire Police provided their closing statement.

Members attention was drawn to Section 9 of the Revised 182 Guidance in determining actions that are appropriate for the promotion of the licensing objectives. Paragraph 11.20 stated:

“In deciding which of these powers to invoke, it is expected that licensing authorities should, so far as possible, seek to establish the cause or causes of the concerns which the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response.”

(Licensing Officers, Lincolnshire Police and the Applicants left the Chamber during deliberation from the Committee.)

Following deliberations, the Committee came to a decision which was read out by the Legal Advisor.

Decision

The Committee have read all the paperwork before them. They have heard from the Licensing Manager, Lincolnshire Police and the premises licence holder. Lincolnshire Police advised of the instances where illegal workers were found at the premises. Furthermore, there had been multiple breaches of annex 1 and annex 2 of licence conditions – details were set out in the statement from PC Braithwaite which included failure to provide training statements and incorrect measures of alcohol, alcohol being served without the personal licence holder being on the premises.

Mr Nazar and Ms Hosseini advised the Committee that Ms Hosseini had been picking up her son and had not been on premises. Mr Nazar advised her had checked the passports and visas of the 2 people on the premises and had told them they could train only. He had been on holiday so was unaware of what happened. He had taken copies of the passports and visas but had not produced them and the matter was with their Solicitor.

Mr Nazar advised there were no training records as it was only him and his wife. He had been unable to find their other documents or details of alcohol measurements.

Mr Nazar advised his wife had been picking up the children and later said she had been in the kitchen when alcohol had been sold.

The Committee considered all options available to them. They did not consider conditions appropriate as there were already failures to comply with conditions. They did consider excluding a licensable activity and removing the DPS but having listened to the evidence put to them, did not consider it would be appropriate for the promotion of the licensing objectives.

The Committee did not consider suspension to be appropriate given the evidence before them.

The Committee therefore decided having full consideration of all the information in the paperwork and what they had heard from all parties that it was appropriate for the promotion of the licensing objectives of prevention of crime and disorder and protection of children from harm to REVOKE the premises licence.

There is a right of appeal to the Magistrates' Court within 21 days of the licence decision being received.

1. Implications

Taking into consideration implications relating to finance and procurement, legal and governance, risk and mitigation, health and safety, diversity and inclusion, staffing, community safety, mental health and wellbeing and the impact on the Council's declaration of a climate change emergency, the following implications have been identified:

Finance and Procurement

- 1.1 There are no specific financial implication associated with this report, however, in the event of an applicant, responsible authority or interested person making an appeal against a decision which was then subsequently upheld, the council may incur additional costs.

Legal and Governance

- 1.2 The Licensing Act 2003 provides a procedure whereby a premises licence can be reviewed at any time on the application of an interested party or a responsible authority. On receipt of an application for review of a licence, the council is obliged to hold a hearing to consider the application. In determining the application, the committee should consider guidance issued under S182 of the Act and the Council's own Statement of Licensing Policy, together with all representations. The decision of the committee should be no more than an appropriate and proportionate response to the concerns raised.

Community Safety

- 1.3 Community Safety implications will be considered in accordance with the licensing objectives and the duty to consider in accordance with S17 of the Crime and Disorder Act 1998

2. Background to the Report

- 2.1 On 26th March 2025 an application for the review of the premise licence for Zorbas, Stamford was received from Lincolnshire Police along with supporting documents (**Appendix 1**). The police also provided supplementary documents to the licensing authority and request that they are allowed to present this to committee to discuss these confidentially within a private session, without the Premise Licence Holder present or the documents to be made public, due to sensitive information contained within it.
- 2.2 The application for the review relates to the following licensing objectives: -
- Prevention of Crime and Disorder.
 - Protection of Children from harm.

- Public Safety
 - Prevention of Public nuisance
- 2.3 Lincolnshire Police advise that they have obtained evidence which indicates that the management of these premises have been operating in such a manner that amounts to criminal activity and thus undermines the licensing objectives. This includes:
- Allegations of criminal offences that have taken place at the premises
 - Breach of hours authorised for licensable activities
 - Breach of Annex 2 and Annex 3 premise licence conditions
 - Concerns over the management involved in the premises
- 2.4 No representations have been received from any of the other responsible authorities. A number of comments from members of the public in support of the premises have been sent into the licensing authority (**Appendix 3**).
- 2.5 A copy of the current Premise Licence 5001 is at (**Appendix 4**). This Licence permits Late Night Refreshment from 23:00 to 00:30 Sunday to Tuesday and 23:00 to 02:30 Wednesday to Saturday, with the same for opening hours. This licence has been in force since it was transitioned over in November 2005.
- 2.6 The current licence holder Seyit Ali Dogan has held Premise Licence 5001 since May 2016, which is when it was transferred into his name.
- 2.7 There has been previous enforcement regarding the premise, including a review application and historic rejected paperwork, due to inaccuracies contained within them:
- a) An application for a separate new premises licence for the same premises was granted in December 2009. This was to permit the off sale of alcohol only, and the licence holder and designated premises supervisor was in the name of a Caner Kaya. This licence was then revoked by licensing committee in September 2012, following a review application by trading standards, due to illegal and poisonous vodka being seized from within the premises. A copy of the decision notice of this meeting are in the background papers.
- The magistrates then upheld the revocation at an appeal hearing in April 2013.
- b) An application for a Minor Variation to the original Premise Licence 5001 was submitted in September 2017, in relation to the late-night refreshment activity. This variation was refused as the application had been signed by Caner Kaya and had not been made in the name of the current licence holder, Seyit Ali Dogan. Similarly, a transfer consent form in the current name of Caner Kaya was submitted to the licensing authority in May 2018, and was subsequently refused

due to this being the wrong licence holder and a lack of application with payment. A copy of the refusal letters are in the background papers.

- 2.8 There is a history of TENS (Temporary Event Notices) on record submitted from 2010 to 2020, for the extension of Late Night Refreshment at the premises. No further TENS have been submitted after March 2020.

3. Key Considerations

- 3.1 Members must take such steps (if any) as they consider appropriate for the promotion of the licensing objectives as outlined in Licensing Act 2003 at section 167(6):

The Licensing Committee may:

- modify the conditions of the licence;
- exclude a licensable activity from the licence;
- remove the designated premises supervisor;
- suspend the licence for a period not exceeding 3 months; or
- revoke the licence.

Alternatively, the Committee may consider that no action is required or that a warning should be issued and/or recommend improvement within a particular period.

- 3.2 The guidance issued under Section 182 of the Act is:

“In deciding which of these powers to invoke, it is expected that licensing authorities should, so far as possible, seek to establish the cause or causes of the concerns which the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response.”

(Paragraph 11.20 of the guidance Issued under S182 of the Act.)

- 3.3 If members decide to take the steps referred to in (a) or (b) above, it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.

4. Reasons for the Recommendations

- 4.1 Application for review has been received from Lincolnshire Police. On receipt of an application for review of a licence by a responsible authority, the council is obliged to hold a hearing to consider the application.

5. Consultation

- 5.1 Statutory 28-day consultation has taken place from 25th March 2025 until 23rd April 2025. The Licensing Authority has fulfilled its obligations under the Licensing Act 2003 by preparing a notice which has been displayed at the premises and published on our website.

This review application relates to a premises which operates as a takeaway and has been granted Premises Licence 5001 (Licensing Act 2003) by South Kesteven District Council.

The licence authorises late night refreshment between the hours of 23:00 to 00:30 Sunday to Tuesday and 23:00 to 02:30 Wednesday to Saturday.

The permitted opening hours of the premises are 16:00 to 00:30 Sunday to Tuesday and 16:00 to 02:30 Wednesday to Saturday.

Lincolnshire Police have obtained evidence which indicates that the management of these premises has been operating it in such a manner that amounts to criminal activity and thus undermines the licencing objective of the prevention of crime and disorder.

The premises has been found trading beyond its authorised licenced hours, along with being in breach of its annex 2 and 3 premises licence conditions which constitutes offences under s.136 Licensing Act 2003 – unauthorised licensable activity.

Lincolnshire Police have also received reports that have raised concerns for the safety of those using the premises. Recent information received has caused the police to question the ability of the premises to uphold the licensing objectives of public safety, public nuisance and protection of children from harm.

In relation to this review application the following guidance issued under Section 182 of the Licensing Act 2003 has been considered:

Revised Guidance issued under Section 182 of the Licensing Act 2003

Section 2.1 states licensing authorities should look to the Police as the main source of advice on crime and disorder.

Section 2.3 states conditions should be targeted on deterrence and preventing crime.... For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers.

2.8 states Licence holders have a responsibility to ensure the safety of those using their premises, as a part of their duties under the 2003 Act.

2.9 states a number of matters should be considered in relation to public safety. These may include:

** Ensuring appropriate and frequent waste disposal*

** Considering the use of CCTV in and around the premises (as noted in paragraph 2.3 above, this may also assist with promoting the crime and disorder objective).*

2.21 states the 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences...The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.

2.28 states the protection of children from harm includes the protection of children from moral, psychological and physical harm... Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.

3.12 states Schedule 2 to the 2003 Act provides a definition of what constitutes the provision of late-night refreshment. It involves the supply of 'hot food or hot drink' between the hours of 23.00 and 05.00 to the public for consumption on or off the premises. It includes the supply of hot food or hot drink between those hours on premises to which the public has access.

3.21 states the provision of late-night refreshment is regulated primarily because it is often linked to alcohol-fuelled crime and disorder in the night-time economy, such as at fast-food takeaways where late-night drinkers congregate.

3.35 states it is a criminal offence under section 136 of the 2003 Act to carry on any of the licensable activities listed at paragraph 3.2 above other than in accordance with a licence or other authorisation under the 2003 Act. The fine for this offence is unlimited. Police and local authorities have powers to take action in relation to premises carrying on unauthorised activities

All of the section 11 guidance is based on reviews:

Section 11.23 states where the premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough action to tackle the problems at the premises.

Section 11.24 states a number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises, money laundering by criminal gangs, the sale of contraband or stolen goods, the sale of firearms, or the sexual exploitation of children. Licensing authorities do not have the power to judge the criminality or otherwise of any issue. This is a matter for the courts. The licensing authority's role when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure the promotion of the crime prevention objective.

Section 11.25 states that in any case, it is for the licensing authority to determine whether the problems associated with the alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives.

Section 11.26 states that it is the role of the Licensing Authority to take steps to promote the licensing objectives in the interests of the wider community and not those of the individual licence holder.

Section 11.28 states it is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be seriously considered.

South Kesteven District Council statement of licensing policy (2021 – 2026) also raises the following points that are deemed relevant to this application:

General

4.1 Each of the four licensing objectives is of equal importance. The Licensing Authority considers the effective and responsible management of the premises and the instruction, training and supervision of staff and the adoption of best practice to be amongst the most essential control measures for the achievement of the licensing objectives.

4.3 The Prevention of Crime and Disorder

In accordance with the Guidance, Police views on matters relating to crime and disorder will be given considerable weight. There are many steps an applicant may make to prevent crime and disorder. The Licensing Authority will look to the Police for the main source of advice on these matters. (those relevant to this application are below)

- *Provision of CCTV in and around the premises.*

4.4 Public Safety

- *Provision of CCTV*

4.4 Prevention of public nuisance

- *The hours of opening, particularly between 23.00 and 07.00*
- *The upkeep of the area immediately surrounding the premises such as litter collection.*

4.5 Protection of children from harm

- *The protection of children from harm includes the protection of children from moral, psychological and physical harm.*

16.1 Reviews

The Licensing Authority will consider the full range of powers available to it when a review of a premise licence becomes necessary. The power to review premise licences represents a crucial protection for the community, especially with regards to the promotion of the four licensing objectives. Reviews of licences may be triggered at any stage by Responsible Authorities or interested parties because of a matter arising at the licensed premises relating to one of the four licensing objectives.

18.1 Enforcement

The Licensing Authority has established protocols with the Police and other enforcing Authorities. These protocols will provide for the targeting of agreed problem and high-risk premises, whilst applying a lighter touch to low-risk premises.

The premises under review is a late-night food takeaway establishment located in the centre of Stamford town centre.

The premises has historically benefitted from two separate premises licences, one for alcohol sales and another for late-night refreshment. In 2012 Trading Standards took the alcohol licence to review due to illegal and poisonous vodka being seized from within the premises. The alcohol licence at the time was held by a Mr Caner Kaya. The decision was made by the committee to revoke this licence.

The late-night refreshment licence for the premises remained in place and was held at the time by two other individuals. This is the licence which the police now seek a review. The current premises licence holder (PLH) is now a Mr Seyit Ali Dogan. Mr Dogan has held the premises licence since it was transferred to him in 2016.

In **June 2017**, Mr Dogan was interviewed by police and issued with a caution for Licensing Offences committed at this premises under the Licensing Act 2003. He fully admitted the section 136 offences of unauthorised licensable activity – serving after hours in April 2017, in addition to non-compliance with licence conditions (CCTV not recording for the required number of days) in May 2017. The caution also included an offence under section 57 of the act by having no copy of the full licence on the premises.

In **December 2024** the police received two separate allegations of serious criminal offences directly connected to the premises. The details of the first offence cannot be disclosed publicly due its sensitivity. When police approached the premises for CCTV footage crucial to this investigation, CCTV could not be viewed or retrieved. The officer in case had requested the footage within the 28-day retention period as per the annex 3 premises licence condition however the officer did suspect that the CCTV may have been purposely deleted. This poses serious integrity concerns. *(Evidence from the victim and officer in case (appendix 5 and 7 respectively) will be disclosed in private session during hearing).*

The second offence alleged later in December 2024 involved a report of sexual assault. This offence is still under investigation by the police. The female victim and male suspect were both customers inside the premises at the time when the alleged offence took place. Upon the officer in case making enquiries into CCTV at the premises, they were informed that CCTV footage was only retained for 21 days. The retrieval of CCTV would have been crucial to the investigation and may have clearly captured the offence had it been recording correctly.

The victim of the first offence alleged in December 2024 had disclosed that the premises had been open and serving hot food at 0300hrs on a Saturday morning. This led the police and SKDC Licensing Team to begin further

investigation into whether the premises was regularly exceeding its authorised hours.

On the **27th February 2025** Police and SKDC Licensing Officers conducted an unannounced compliance check, to ensure the premises was operating within the remit of its premises licence and the associated conditions. Mr Dogan was present and working at the premises at the time. (*see appendix 1 – Pc Braithwaite’s statement for full details of the visit*).

When questioned, Mr Dogan was unable to recall the reason he was interviewed and cautioned by the police in 2017. He could not provide a copy of his full premises licence, nor did he have his summary on display in the shop. This is an offence under s.57 of the Licensing Act 2003. Mr Dogan could not recall any of his licence conditions at all. When his opening and late-night refreshment hours were read out to him, he acknowledged he was aware of these timings.

During the inspection it was also noted that no notice was displayed within the premises requesting customers to respect the needs of the local residents and leave the premises quietly and dispose of rubbish responsibly. This contravenes the condition within annex 2 of the licence, which is a s.136 offence under the Licensing Act 2004 – unauthorised licensable activity.

When police attempted to check the premises CCTV to ensure it was compliant in line with the annex 3 condition of the licence, they were unable to achieve this for reasons outlined within Pc Braithwaite’s statement (*see appendix 1*). This was progressed with Mr Dogan in the days that followed, however to date, Mr Dogan has failed to provide police with the CCTV footage as requested (*see appendix 2 – emails 1,2,3 – communication between Mr Dogan & Pc Braithwaite, and appendix 3 – Zorba’s CCTV summary*). As with the two separate occasions in December 2024, Mr Dogan has been non-compliant with the condition to evidence that CCTV is maintained and kept for no less than 28 days and made available to police if required. This is a further s.136 offence under the Act.

It is also worth noting that during the premises inspection on the 27th February 2025, Mr Dogan showed us around the three floors directly above the takeaway shop. He confirmed he leased the whole building. Several bedrooms containing various beds were located within the three floors. Mr Dogan was quite evasive about who occupied these rooms and what their purposes was. A fire safety referral was submitted due to concerns that were presented. On the 25th March 2025 Lincolnshire Fire confirm that an inspection had been completed, and they had issued a prohibition notice as the accommodation was found unsafe for people to sleep at the premises. They also intend to issue an enforcement notice for this premises. (*See appendix 8 for email*). This highlights Mr Dogan’s inability to follow safe practices.

It has now been confirmed via SKDC CCTV footage that on the following three occasions, the premises has been open to the public and serving hot food well beyond its authorised time of 0230hrs. These occasions include:

- **Sunday 12th January 2025** (see appendix 4 for full details)
- **Sunday 9th February 2025** (see appendix 4 for full details)
- **Sunday 23rd February 2025** (see appendix 6 for full details)

Upon reviewing the CCTV from the 23rd February 2025, another breach of condition was highlighted. On this occasion, when the premises does eventually close and turn its lights off at 0424hrs that morning, an extensive amount of litter can be seen on the street and overflowing from the public litter bin next door to the premises. Staff are not seen attempting to clear this away. The premises licence has an annex 3 condition stating that the public area immediately surrounding the premises shall be cleared of waste food, food containers wrapping etc at the end of trading on each day. This did not appear to take place and as such a further s.136 offence was committed.

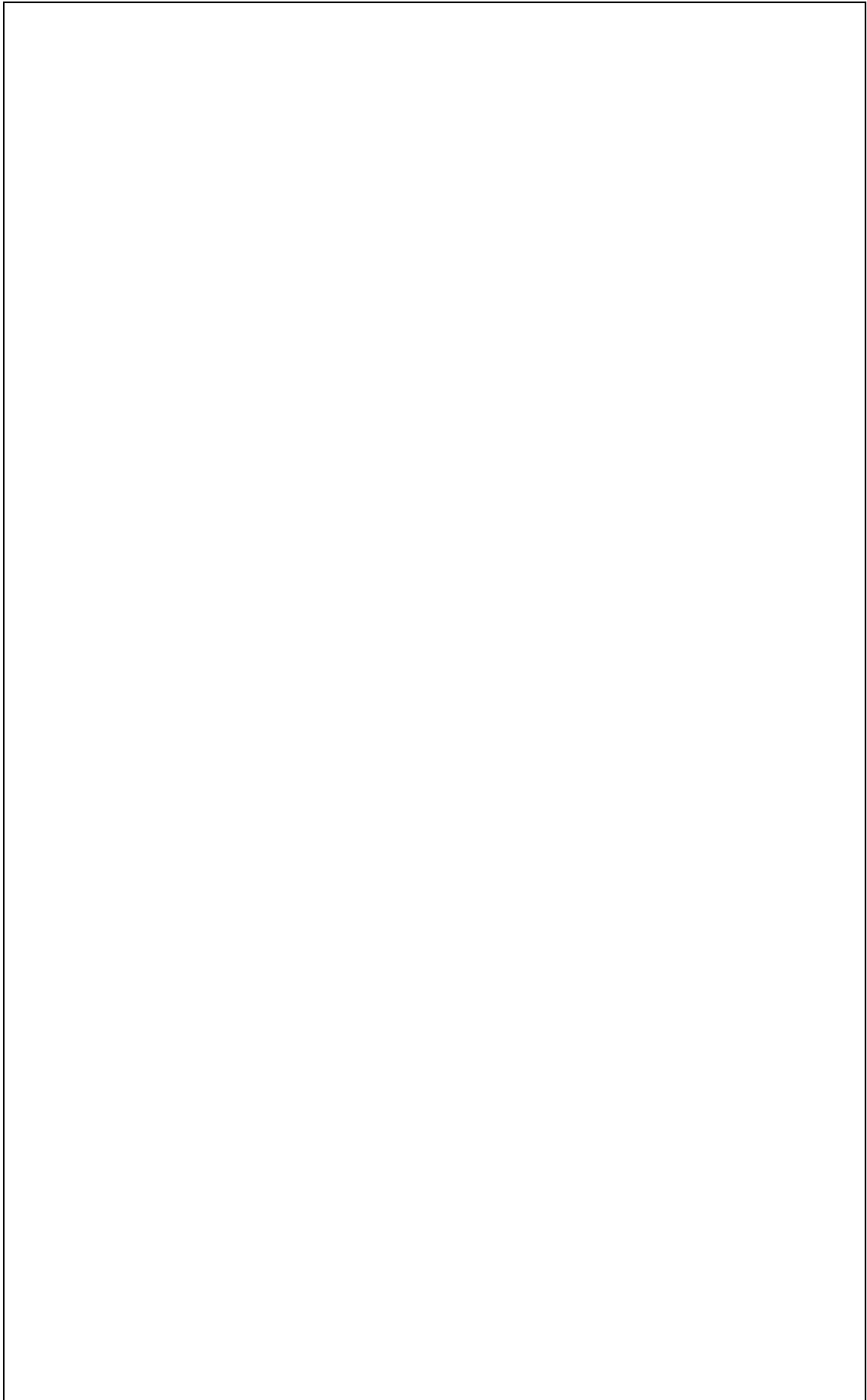
This month, a new crime has been reported to Lincolnshire Police which raises concern as to whether the premises is upholding the licencing objective of the protection of children from harm. Again, the details of this offence cannot be disclosed publicly due its sensitive nature, and further information will be disclosed in private session during hearing.

What has become evident during the two most recent police investigations, is that Mr Caner Kaya is still acting in the capacity of manager at the premises. This is obviously a concern to the police, given the fact he was the licence holder for the previous alcohol licence which was revoked at hearing due to illegal and poisonous vodka being seized from within the premises. Mr Kaya has been described as the manager and point of contact officers investigating into the recent offences have liaised with as part of their investigation.

Mr Dogan has previously been warned by the police in the form of a police caution regarding his actions as PLH, but regardless of this, the same issues with his management of the premises continues. This shows a complete disregard for the rules, and highlights concerns around his level of competency in this role. There also appears to be a degree of 'covering up' going on by staff and management, to hide the true activities of the premises, which is a significant concern.

By blatantly and illegally opening until as late as around 0400hrs during the weekend, this undoubtable attracts a higher level of risk due to the nature of the trade and level of intoxication of customers. The premises licence was not written with this far later trading time in mind.

Lincolnshire Police have no confidence in the ability of Mr Dogan to uphold the licensing objectives and respectfully request that the committee seriously consider the revocation of this premises licence.

Lincolnshire Police made a representation to support a review application made by Lincolnshire Trading Standards in 2012. 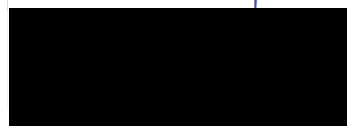



I am the above named person employed as a Police Constable within Lincolnshire Police. I currently work in the Alcohol Licensing Team and predominantly cover the North and South Kesteven District areas of the county.

On Thursday 27th February 2025 I was on duty and in company with Neighbourhood Policing colleagues and Heather Green, Licensing Manager for South Kesteven District Council Licensing Team. At approximately 1725hrs we attended a licensed premises, Zorbas, 40 Broad Street, Stamford, PE9 1PX. The purpose of the visit was to conduct an unannounced compliance check, to ensure the premises was operating within the remit of its premises licence and the associated conditions.

Upon arrival, the premises was open for business and the male behind the counter introduced himself as Seyit Ali Dogan, the owner. Mr Dogan is the premises licence holder for Zorba's, which benefits from a late-night refreshment licence.

No premises licence summary was on display within the premises which is an offence under s.57 of the Licensing Act 2003. A further offence under this same section was committed due to Mr Dogan being unable to present the full premises licence.

I began talking to Mr Dogan about the hours the premises was authorised to open and serve late night refreshment as per his licence. He agreed he was aware of these timings.

When I asked if Mr Dogan was familiar with the conditions of his licence, he stated he was. When I asked him to tell me what the conditions of his licence were, he could not provide any at all.

I reminded Mr Dogan that he had been interviewed by police regarding licensing offences in 2017 when he subsequently received a police caution, but his response was very vague. After a little while he did admit he could remember the interview, but when I asked what the interview was regarding, he said 'a complaint', 'some fighting that happened here'. I reminded him that he was actually interviewed about not having his premises licence on the premises, opening beyond his hours and having CCTV issues. Mr Dogan then simply said he recalled his CCTV was not working at the time.

Mr Dogan said his CCTV was now working and attempted to show me a display monitor located in the kitchen area. It appeared to display four different views, but due to the extremely poor quality it was impossible to make out. I asked how he controlled it, and he said it was via his other mobile phone which he did not have with him. Mr Dogan said there was no hard drive, and the cameras were connected via the internet. He pointed to a 'Ring' camera that was positioned behind the counter facing towards the public waiting area. Mr Dogan stated he had contacted a friend to bring his other phone to the premises so we could look at the footage. We remained at the premises for approximately another 45 minutes, but Mr Dogan's second mobile phone did not arrive.

I explained to Mr Dogan that I would email him a list of footage I would need him to provide to me so I could ensure his CCTV system was operating within the conditions of his licence. I also wanted to check this footage to ensure the premises was not opening beyond its authorised times.

Whilst conducting my inspection, I discovered no notices were displayed at all within the premises requesting customers respect the needs of the local residents and leave the premises quietly and dispose of rubbish responsibly. This contravenes the condition within annex 2 of the licence, which is a section 136 offence under the Licensing Act 2004 – unauthorised licensable activity.

Whilst completing the premises inspection, Mr Dogan showed us around the three floors directly above the takeaway shop. He confirmed he leased the whole building. Several bedrooms containing various beds were located within the three floors. Mr Dogan was quite evasive about who occupied these rooms and what their purposes was.

Upon my return to the police station that evening, I completed a safety referral to Fire due to concerns that were presented to me in terms of the presentation of the accommodation above the premises. I have since received an email from Rob Strutt a Fire Safety inspector for Lincolnshire Fire and Rescue (*see appendix 8*). In it, he confirms that an inspection had been completed, and they had issued a prohibition notice as the accommodation was found unsafe for people to sleep at the premises. They also intend to issue an enforcement notice.

Also, upon my return to the station on the 27th February 2025, I emailed Mr Dogan a list of the footage I required him to send to me via email (*see 'email 1' in appendix 2*). Having previously received information that the premises had been staying open beyond its licenced hours, I requested footage for all Friday and Saturday openings within the past 28 day period between the hours of 0215hrs-0330hrs.

Mr Dogan responded on the 1st March 2025 (see *'email 2' in appendix 2*). stating he had managed to find all the footage I had requested and had attached 12 individual links to 'Ring' footage. He also mentioned that he had set up new camera devices with improved views at the premises. I can confirm the footage provided was a mere fraction of what I had requested (see *appendix 3 – Zorba's CCTV summary*) where the content is documented. Mr Dogan never did respond to my request to clarify if the date and time on his footage was running correctly, so I can only assume these as they are presented in the footage.

On the 3rd March 2025, I responded to My Dogan by email explaining that the CCTV clips he had sent me did not satisfy my original request, and again re-iterated the footage that I originally requested. I asked for this to be provided to me by midday the following day. He replied the same day giving the excuse that they were 'motion cameras' and had been 'playing up', but he could 'try getting more clips. I once again responded, asking for clarification as to whether he could actually provide what I had requested. Mr Dogan replied and said he would need to 'get the old camera system back out to find out'. At this point in the communication, I stressed the importance of the annex 3 CCTV condition, and once again asked for this footage by midday the following day. I took this opportunity to explain that I was aware that on the two previous occasions police had attempted to obtain CCTV to investigate alleged crimes directly linked to the premises in December 2024, they were also unable to obtain any footage. I stressed that this had hindered the police investigations as a result. I further explained that I would be taking action against the licence, should the footage I had been requested not be provided. (see *'email 2' in appendix 2 for email communication*).

Mr Dogan then sent two separate responses to this final email I sent to him (see *'email 2 and 3' in appendix 2*) simply not addressing the point I had raised, talking about the installation of new systems within the premises which was irrelevant.

Mr Dogan's inability to provide the CCTV footage I requested contravenes the annex 3 premises licence condition to have CCTV that is maintained with footage kept for no less than 28 days

Mr Dogan,

Your premises licence has a clear condition within its annex 3 that **CCTV should be maintained and kept for a period of no less than 28 days, and made available to police if required.**

Ordinarily if CCTV footage at a premises cannot be shown to police upon request, (which was the case on Thursday afternoon during my visit), police would then allow the premises licence holder a standard period of 24 hours to provide the footage within.

Since I requested this footage on Thursday evening, I believe that by allowing you **until midday tomorrow** to produce the footage, is more than sufficient time for this request.

I have noted that the police have had similar issues in retrieving footage from your premises in relation to two separate reported crimes that were directly linked to your premises in December 2024. Despite officers best efforts, footage from both incidents was never obtained, and as such this failure to provide the footage hindered the police investigations.

As you can understand, I have serious concerns regarding this breach of your licence, and will be forced to take action against your licence if you cannot provide the footage I have requested.

Mr Dogan,

Your premises licence has a clear condition within its annex 3 that **CCTV should be maintained and kept for a period of no less than 28 days, and made available to police if required.**

Ordinarily if CCTV footage at a premises cannot be shown to police upon request, (which was the case on Thursday afternoon during my visit), police would then allow the premises licence holder a standard period of 24 hours to provide the footage within.

Since I requested this footage on Thursday evening, I believe that by allowing you **until midday tomorrow** to produce the footage, is more than sufficient time for this request.

I have noted that the police have had similar issues in retrieving footage from your premises in relation to two separate reported crimes that were directly linked to your premises in December 2024. Despite officers best efforts, footage from both incidents was never obtained, and as such this failure to provide the footage hindered the police investigations.

As you can understand, I have serious concerns regarding this breach of your licence, and will be forced to take action against your licence if you cannot provide the footage I have requested.

I look forward to hearing back from you.

Hi Kat, we currently have CCTV footage from 12/1/25 and 9/2/25.

On 09/2/25 footage, it again starts at 2:30am with lots of customers in the vicinity. They do eventually disperse and it appears quiet until the 2:51am mark, when again a man who appears to be a worker appears at the doorway to stand and look outside, he then starts greeting customers walking by and appearing to serve them from the doorway. Further customers arrive even at 3:15am mark and go to the doorway, being given a pizza box a couple minutes later. This continues sporadically with other customers appearing to wait outside for food, until the footage stops at 3:30am.

On the 12/1/25 9/2/25 footage, it starts at 2:30am and appears to show patrons still inside the premises with further ones entering and sitting down. At 2:48am mark further customers try to enter although the door appears to be locked. They then enter the premise a minute later and sit down. Further customers arrive and are let in at the 2:56am mark. Some of the lights appear to darken at 2:59am, but there are still customers outside that appear to being served by the door after this. A customer leaves with a pizza at 3:12am. A break in customers after this. At the 3:22am mark, a gentleman who appears to work there comes out to stand by the doorway and look outside. Further customers come to the door at the 3:34am mark and leaving with pizza boxes a minute after. A stream of customers come and leave with food up until the footage ends at 3:50am.

We have the following reports from CCTV too

- I was on a night shift on Saturday night (09/02/2025), and I saw that Zorbas were still serving food after 02:30hrs. This was at 03:00hrs, I could see that people were coming out of the night club next door. Zorbas had got the shop lights off and a male was stood in the doorway taking orders and then was passing the food to them outside the door, so there were not allowing people in the shop but working orders just outside the shop

- Good morning, For your information Zorba's on Broad Street, Stamford appeared to still be open past 02:30 on Saturday night (11-12/01/25). Last group of people seen leaving with pizza boxes at 03:50. Footage available if required (ST80).
- I was on a night shift on **Saturday 22/02/25** and was monitoring Zorbas after 02:30hrs, they continued to serve up until 04:00hrs.
 - At 02:57hrs x4 young people went into Zorbas and came out 03:01hrs with food and soft drinks.
 - At 03:35hrs x2 young girls went into Zorbas and came out with pizzas.
 - 03:47hrs the night club around the corner had closed and groups of young people queued outside Zorbas for food. This time the door was closed and a white male was stood in the door way taking orders and the food was being handed out from the shop to the customers on the street. The lights were all turned off in the shop from 02:30hrs.

Hi Kat,

I have been asked to give you a quick update with regards to the above-mentioned premises.

I visited this premises on 28th February. We found that the fire alarm had been cut and as a result no means of giving warning to people sleeping. As you saw as well, we had major defects in fire safety compartmentation (doors being damaged) and as a result lead to us issuing a prohibition notice as it is currently not safe for people to sleep at the premises. We have sent a couple of Article 27 letters to establish who has control over the building in terms of the freeholder and leaseholder, and we are still awaiting responses from these. Once we have established these, we will be issuing an enforcement notice which will work alongside the prohibition notice.

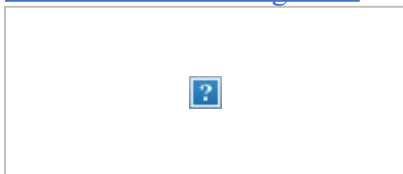
It would be good to see the council support this business, you can see the impact they have on the community even by the shirts they display in the takeaway where they sponsor local teams.

- Equally to comply with the reasonable guidance of the police, Council or any other relevant authority to promote the licensing objectives

b) The prevention of crime and disorder
