Boston – Under Scrutiny Procedure Rules

17. The Party Whip

17.1

(a) The DETR Guidance views whipping as incompatible with Overview and Scrutiny.

(b) When considering any matter in respect of which a Member of the Overview and Scrutiny Committee is subject to a party whip the Member must declare the existence of the whip and the nature of it before the commencement of the Committee's deliberations on the matter. The declaration, and the detail of the whipping arrangements, shall be recorded in the minutes of the meeting.

A Party whip is "Any instruction given by or on behalf of a political group to any Councillor who is a Member of that group as to how that Councillor shall speak or vote on any matter before the council or any Committee or sub-committee, or the application or threat to apply any sanction by the group in respect of that Councillor should he/she speak or vote in any particular manner."

There is also a brief section in the Planning rules that suggest that an Ombudsman has previously said political whipping is incompatible with Planning decisions.

East Lindsey – Under Scrutiny Procedure Rules

17. The party whip When considering any matter in respect of which a member of Overview Committee is subject to a party whip, the Councillor must declare the existence of the whip and the nature of it before the commencement of the Committee's deliberations on the matter. The declaration, and the detail of the whipping arrangement, shall be recorded in the minutes of the meeting.

Lincoln – Same reference as Boston to Planning Committee decisions.

Lincolnshire – References are mainly to the role of Chief Whip which only exists at LCC.

North Kesteven – no reference to whipping arrangements

South Holland - no reference to whipping arrangements

West Lindsey – no reference to whipping arrangements
