**Supply of alcohol**

1. No supply of alcohol shall be made under this Premises Licence at a time:
  - a) When there is no designated supervisor in respect of the Premises Licence
  - b) When the designated premises supervisor does not hold a personal licence or his or her personal licence is suspended.
2. Every supply of alcohol under the Premises Licence shall be made or authorised by a person who holds a personal licence.

**SCHEDULE Mandatory Licensing Conditions**

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either –
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.

**Mandatory condition preventing the sale or supply of alcohol below the permitted price.**

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
2. For the purposes of the condition set out in paragraph 1
  - (a) “duty” is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) “permitted price” is the price found by applying the formula:-
$$P = D + (D \times V) \text{ where:-}$$

P is the permitted price,

- i) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- ii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence:-

- i) the holder of the premises licence,
- ii) the designated premises supervisor (if any) in respect of such a licence, or
- iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

**Steps Taken To Promote the Licensing Objectives**

**a) General - all four licensing objectives (b,c,d,e)**

I have put some more training on for my staff about alcohol sales.

Installed new signs and new cameras.

**b) The prevention of crime and disorder**

The premises shall operate the "Challenge 25" Proof of Age Policy to prevent the sale or supply of alcohol to persons under 18 years of age. The policy shall require any person who appears to be under the age of 25 years to produce one of the following forms of identification:

\* A recognised proof of age card credited under the British Retail Consortiums Proof of Age Standards Scheme (PASS);

\* Photo driving licence;

\* Passport;

\* Any other means of identification approved and accredited in writing by Lincolnshire Police;

\* Failure to produce satisfactory proof of age shall result in a refused sale.

A CCTV system shall be installed, recording and maintained in working order and operated at the premises to the satisfaction of Lincolnshire Police, specifically

There shall be a minimum of one high-resolution colour camera fitted to the public entrance/exit to provide a quality head and shoulder image for facial recognition/identification purposes of all persons entering the premises.

There shall be sufficient cameras able to cope with the normal operating illumination to cover all licensed public areas.

Recording must be kept for a minimum of 31 days and endorsed with the accurate correct time/date (BST/GMT adjusted).

Police and/or Licensing Officers shall be able on attendance to view playback of any incident without the necessity for download.

Recordings of incidents at the premises must be provided to the police

following lawful request.

A member of staff shall be on the premises at all times they are open to the public who is capable of operating the CCTV system and providing recordings on request.

Recording equipment shall be housed in a secure room/cabinet where access and operation is strictly limited to authorised persons.

**c) Public safety**

Fire safety training and evacuation procedures. Alcohol display should be in secure area.

Great effort must be made to inform the public of the dangers of alcohol.

Specifically providing clear health warnings both where alcohol is displayed and point of sale.

**d) The prevention of public nuisance**

The opening hours are not in unsocial time creating an environment that controls nuisance by training staff to increase their awareness so they can assess potential risks and work towards minimising possible disturbances.

We have put high resolution cameras (1080) in place.

All the staff members are trained again about alcohol sales.

**e) The protection of children from harm**

Notices shall be prominently displayed advising customers of the "Challenge 25" policy.

All point of sale staff shall undergo training in the proof of age policy with a record of the date of the training and signed by the person trained and the person providing the training.

Such a record of training shall be kept for a minimum of 24 months from the date of completion and made available for inspection by the Police.

We will put some more awareness and education about alcohol signs in the shop.
